## Who can participate?

To be considered for participation in the HELIOS+ project, you must meet all three of the following criteria:

### **You must hold one of the following:**

- Refugee status or subsidiary protection from the Greek Asylum Service, or
- Temporary protection status, or
- Residence permit through family reunification with a recognized refugee, or
- Equivalent residence permit as a family member of a beneficiary of international protection.

Your registration in HELIOS+ must take place within 24 months from the date of the decision granting protection status or a temporary residence permit.

You must be unemployed at the time of registration in the project.
